ENACTED by the Ekiti State House of Assembly as follows:

*Amendment of
Ekiti State Gender-
Based Violence
(Prohibition) Law
No. 18 of 2019.*

1. The provisions of the Ekiti State Gender-Based Violence (Prohibition) Law, No. 18 of 2019 (in this Law referred to as “the Principal Law”) is hereby amended as set out in Law.

Section 2 (2) (c)
of the Principal Law.*

2. Section 2 (2) (c) of the Principal Law is hereby deleted and substituted with another Section 2 (2) (c) as follows:
Section 2 (2) (c): in the case of rape by a group of persons, the offenders shall be liable jointly to life imprisonment.

Section 62 of the
of the Principal Law.*

3. Section 62 of the Principal Law is hereby deleted and substituted with another Section 62 as follows:
***Section 62:
The provisions of this Law shall be without prejudice to similar provisions in Ekiti State Female Circumcision (Prohibition) Law CAP. E.13, 2002, and the Rights of Widows Law CAP. R.6***

Citation.

4. This Law may be cited as Ekiti State Gender-Based Violence (Prohibition) (First Amendment) Law, 2020.
