## A LAW TO AMEND THE PROVISION FOR THE ESTABLISHMENT OF EKITI STATE HOUSING CORPORATION, FOR THE FUNCTIONS OF THE CORPORATION AND FOR OTHER MATTERS THEREWITH.

### EKITI STATE OF NIGERIA.

Commencement [

#### ENACTED BY THE HOUSE OF ASSEMBLY OF EKITI STATE AS FOLLOWS:

Repeal of Ekiti State Housing Corporation (First Amendment) Law, No. 7 of 2016. 1. The provisions of the Ekiti State Housing Corporation (First Amendment) Law, No. 7 of 2016 are hereby repealed.

2. The provisions of the Ekiti State Housing Corporation Law, Cap E20, Laws of Ekiti State, 2012 (in this Law referred to as "the Principal Law") is amended as set out in this Law.

### Constitution of the Corporation.

Amendment of
Section 3 (1)
of the Principal Law

3.

Section 3 (1) of the Principal Law is hereby amended by substituting Section 3 (1) of the Principal Law with a new Section 3 (1) to now read as follows:

Section 3 (1): The Corporation shall consist of –

- a) A Chairman.
- b) The General Manager, who shall be the Chief Executive Officer of the Corporation.
- c) A representative of the Ministry of Lands and Housing.

- d) Three other members one of whom shall be a woman.
- e) A Secretary, not below the rank of a Deputy Director from the Ekiti State Civil Service/Public Service.
- f) A Legal Adviser who shall not be below the rank of a Deputy Director from the Ministry of Justice.
- g) All members shall function on part-time basis except the General Manager, the Secretary and the Legal Adviser.

### Miscellaneous Provisions.

Amendment of Section 20 (1) of the Principal Law

4.

- Section 20 (1) of the Principal Law is hereby amended by deleting the words " *after due consultation with the Corporation*" from Section 20 (1) of the Principal Law to now read as follows:
- Section 20 (1): The Chief Executive Officer of the Corporation shall be its General Manager who shall be appointed by the Governor.

### Citation.

5. This Law may be cited as Ekiti State Housing Corporation (Second Amendment) Law, 2020.
