# A LAW TO MAKE PROVISION FOR THE EKITI STATE POLITICAL OFFICES (GENDER COMPOSITION) AND FOR OTHER MATTERS CONNECTED THEREWITH.

#### **EKITI STATE OF NIGERIA**

Commencement [

#### **ENACTED BY THE EKITI STATE HOUSE OF ASSEMBLY as follows:**

### **Gender Composition of Political Offices.**

1. As from the commencement of this Law, thegender composition of persons holding any of the classes of political offices listed in the schedule shall be not less than 35% and not more than 65% of either sex.

## **Appointment of Governor.**

2. In accordance with Section 208 (4) of the Constitution of the Federal Republic of Nigeria 1999, (as amended), in the making of appointments to Political Offices, the Governor shall have regard to the diversity of the people in the State and the need to promote unity.

### Non-Compliance.

3. Where there is non-compliance with or breach of this Law by reason of resignation, removal from office, death or for whatever reason, any person may petition the Governor who, upon being satisfied that grounds so exist, shall within a reasonable time do such things as are necessary for compliance with the Law.

# Law does not confer right for appointment.

4. Nothing in this Law shall be construed as conferring on a person the right to be appointed to any political office if the person does not otherwise possess the requisite qualifications or requirements for appointment into such office.

# Interpretation.

- 5. In this Law, unless the context otherwise requires-
  - "Governor" means the Governor of Ekiti State
  - "State" means Ekiti State of Nigeria
  - "Within a reasonable time" means a period of time not exceeding two months.

#### Citation.

6. This Law may be cited as the Ekiti State Political Offices (Gender Composition) Law, 2022.
