ENACTED BY THE EKITI STATE HOUSE OF ASSEMBLY as follows:

Amendment of 1. The provisions of the Ekiti State Customary Courts Law, *Ekiti State Customary Principal Courts Law*, No. 4 of 2014 (in this Law referred to as “the Law”) is hereby amended as set out in this Law.

Substitution of 2. Paragraph 7 of the Second Schedule to the Principal Law *paragraph 7 of 7 the Second Schedule to the Principal Law.* Paragraph 7 of the Second Schedule to the Principal is hereby deleted and substituted with a new paragraph as follows:
(7) Causes or matters relating to Landlord and Tenants in respect of customary tenancy where the debt demand or damages do not exceed Two hundred and fifty thousand naira (₦250,000:00) only

Substitution of 3. Paragraph 9 of the Second Schedule to the Principal Law *paragraph 9 of 9 the Second Schedule to the Principal Law.* Paragraph 9 of the Second Schedule to the Principal is hereby deleted and substituted with a new paragraph as follows:
(9) Ejectment of tenant causes or matters in respect of customary tenancy where the rental value of the property does not exceed Two hundred and fifty thousand naira (₦250,000:00) only

Insertion of a new 4. The Schedule to the Principal Law is hereby amended by *Schedule to the and Principal Law.* the insertion of a Fourth Schedule as hereby set out attached.
